RE: SSS SCHOLARSHIP – AN UPDATE

We are pleased to provide you with an update on the above Scholarship, which was launched in February 2010. We are also grateful to Straits Times for providing a large space to feature this Scholarship on 22nd February 2010 (Home B4).

The aim of the Fund is to sponsor initially, one student **each** per year for study at a Junior College **and** at a Polytechnic. It will be worth \$1,000/- annually for two years of study at a junior college, and \$1,500/- annually for three years of study at a polytechnic.

I believe we are the first neighbourhood school to start such a scholarship. Though SES-SSS may have a very humble beginning against a backdrop of students from humble background; and even today most students are from humble-modest background – this need not stop us from pooling our funds to send some of our best students to institutes of higher learning.

As of today, we are pleased that more than 20 donors have come forward with an aggregate sum of approximately \$32,000/-. This sum will allow us to run the Scholarship for few more years. The SAC and the Alumni would like to see the Scholarship run for a much longer haul and also to increase the quantum, as and when the cost of education rises as well; and the number of scholarships too, if we could afford.
